The DSC 3G Swap Program

With the AT&T 2G (GSM/GPRS) sunset date of December 31, 2016 growing closer by the day, you've likely already started thinking about what you need to do to prepare your business for the transition to 3G. While the investment in hardware, service and administration costs may seem daunting, DSC has developed a unique program which reduces the financial impact while upgrading your existing DSC Universal (GS3055-ICF/GS3060), PowerSeries (GS2060/TL260GS) and IMPASSA (GS2055) 2G installations to 3G.

Equipment Purchase

Unlike other upgrade programs which offer mail-in rebates, the *DSC 3G Swap Program* provides cost savings directly at the time of purchase. The DSC upgrade kits focus on replacing the 2G radio and are available for a reduced price, so there is no need to buy a completely new communicator. Simply purchase the desired upgrade kit from your local DSC distributor and you will receive the special price immediately. There is also no need to return the existing 2G communicator in order to be eligible for the discounted price.

Equipment Installation

Once you've purchased the required upgrade kit and arrived on site, the benefits of the *DSC 3G Swap Program* become even more evident with the simplified installation process. Simply follow these basic steps:

1. Replace the existing 2G PCB with the new 3G PCB from the DSC upgrade kit.
2. Transfer the original SIM card into the new 3G communicator.
3. Power up the new communicator and apply the corresponding upgrade labels as per the instructions. The unit will automatically download the existing configuration from C24 Communications.

Simply test the unit and the upgrade is complete. There's no need to perform any account activation (3G) or deactivation (2G) so onsite technician time is minimal.

Account administration

By reusing the existing SIM card there is no activation charge and no impact to your existing C24 Communications billing. Also, since you've already received your 'rebate' at time of purchase, you don't have to spend valuable resources tracking whether or not you've received the applicable credit from your mail-in rebate.

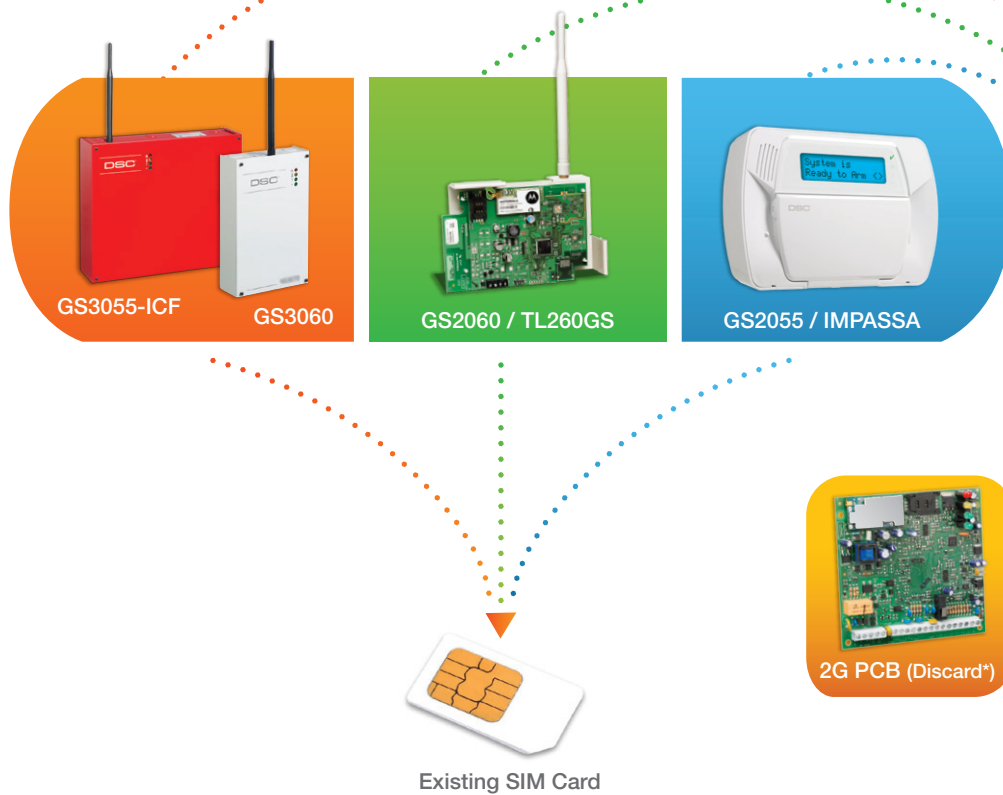

As part of the *DSC 3G Swap Program*, dealers can now return any competitor 2G communicator along with a SIM card* and purchase either a DSC 3G4000 HSPA (3G) Universal Cellular Alarm Communicator or a DSC 3G4010-CF HSPA (3G) Universal Wireless Commercial Fire Alarm Communicator for a reduced price.

**Units returned without the SIM card are not eligible to receive the reduced price.*

DSC's HSPA (3G) Universal Alarm Communicators are designed to work with practically any panel utilizing Contact ID to ensure high-speed, reliable and low-cost communications to your central station.

Unlike competitive upgrade programs which provide delayed savings via mail-in rebates, the *DSC 3G Swap Program* allows you to obtain the benefit of cost savings directly at time of purchase.

As the communicators capture the output from the panel's dialer, there's no need to reprogram central station phone numbers or account numbers as part of the transition.

The communicators are easily installed using the telephone, web or mobile site interfaces provided by C24 Communications.
