



# HS-BB100/HS-BB101 Battery Bracket

## Installation Instructions

### Introduction

The HS-BB100/HS-BB101 Battery Bracket is for use with the DSC Concourse™ Home Systems Wiring Solution. The HS-BB100 allows a battery to be placed anywhere on the right side of any HS-CAB cabinet that has a center raceway. The HS-BB101 allows a battery to be placed anywhere on the left side of any HS-CAB cabinet. The maximum battery size is 6"W x 4"H x 2¾"D.

### Contents of Package

The package contains the following parts:

- one HS-BB100 or one HS-BB101.

### Installation Instructions

1. Locate a suitable mounting location for the bracket inside the cabinet.\*
2. Align the two mounting tabs with the holes in the wire raceway and insert as per Figure A.
3. Snap the bracket into place by pushing the opposite side towards the back of the cabinet.
4. Place the battery on the bracket.

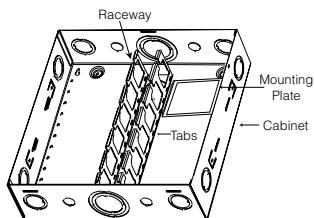
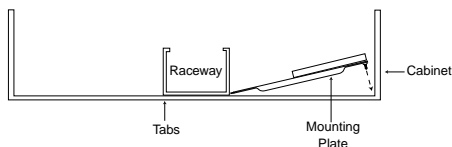

\* There should be a minimum spacing of 1-¼ inches between the top of the battery bracket and the mounting plate above, in order to leave enough room to remove the battery without dislodging the battery bracket. If two battery brackets are used, there should be a minimum spacing of 1-¼ inches between them.

**NOTE:** The HS-BB100 battery bracket cannot be used with the model HS-CAB100 cabinet.
