## Introduction

The MLRV-A is a single-line video receiver module designed to add Downlook video capabilities to the Sur-Gard MLR2-DG Digital Receiver. The MLRV-A Module may be connected to any DRL2A Line Card installed in the MLR2-DG Receiver. In its maximum configuration, the MLR2-DG Receiver can monitor up to 14 digital lines or a combination of MLRV-A Modules and digital lines.

The MLRV-A, via the DML5A backplane, provides for two video outputs: a simple coaxial output to a video monitor and a video data bus output for PC connection. The DLGB Downlook grabber board and the PSA software must be used for PC connection.

### Designing Your Receiver

The following components are used to add Downlook Video capabilities to the MLR2-DG Receiver:

<b>MLRV-A</b>	Single-line Video Receiver Module
<b>MLR2XV</b>	Expansion Card Cage; accommodates one DRL2A Line Card and two MLRV-A Video Modules
<b>MLRXV</b>	Expansion Card Cage; accommodates four MLRV-A Video Modules
<b>MLRX</b>	Expansion Card Cage; accommodates two DRL2A Line Cards

### Follow these guidelines when adding MLRV-A Modules to the MLR2-DG Receiver:

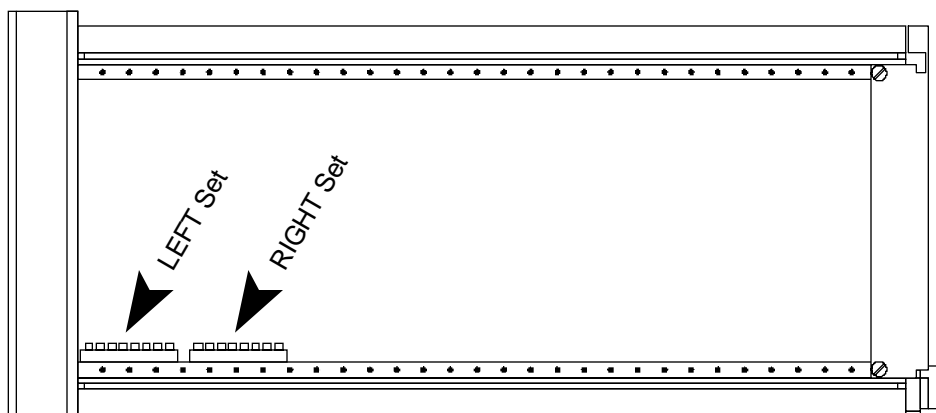
- If several receiver lines are available but only one MLRV-A Module is to be used, it is recommended the MLRV-A be connected to the last line, or on a line by itself.
- Two MLRV-A modules may be used to provide "roll-over" if the first telephone line is busy (for example, if the first MLRV-A is busy, another call would be processed by the second MLRV-A).
- With an MLRV-A module connected, the DRL2A Line Card will still be able to receive non-video accounts. However, it is recommended the number of non-video accounts be limited for DRL2A Line Cards with MLRV-A Modules attached to reduce the possibility of a busy line.

## Program MLRV-A Options

Several video display and operational options on the MLRV-A are programmed with two sets of switches found inside the module. Program these options before installing the MLRV-A Module in the card cage.

### Open the Module

- Be sure to observe proper anti-static precautions when working with the MLRV-A Module.

### **Set the MLRV-A Programming Switches**

- Two sets of DIP switches can be accessed through the open side of the MLRV-A Module. Set the switches following the instructions below:

#### **LEFT Set**

##### **Switches 1 through 3: On-Screen Display Times**

6	Option
OFF	Account Number does not flash

##### **Switch 7: Sounder Option**

7	Option
OFF	Sounder enabled
ON	Sounder disabled

##### **Switch 8: Account Number Display Size**

8	Option
OFF	Small Account Number
ON	Large Account Number

#### **RIGHT Set**

##### **Switches 1 and 2: Factory Test Switches**

These switches are for factory testing only.

##### **Switch 3: Communications Text Option**

3	Option
OFF	DRL2A information not displayed
ON	Display communications text information from DRL2A

##### **Switch 4: Factory Test**

This switch is used for factory testing only.

##### **Switch 5: Not Used**

##### **Switch 6: PAL / NTSC Select**

6	Option
OFF	PAL Video Selected
ON	NTSC Video Selected

##### **Switch 7: Relay 1 Option**

7	Option
OFF	Relay 1 will not activate
ON	Relay 1 activates on alarm for audio recording

##### **Switch 8: 8-second Image Display Option**

8	Option
OFF	Screen clears after last image is received
ON	Last image remains on screen for 8 seconds

### **Install Mounting Screws**

- Insert the four black plastic collars in the four mounting holes in the MLRV-A faceplate.
- Insert the four faceplate screws into the collars.

### **Install the MLRV-A in the Receiver Rack**

- Slide the MLRV-A Module into the Receiver Rack, ensuring the connector on the back of the unit engages the connector on the DML5A Circuit Board secured at the back of the rack
- With the MLRV-A in place, secure the unit with the four faceplate screws

## **Maximum Receiver Configurations**

Each MLRV-A Module draws 220 mA dc, while each Line Card Module draws 150 mA. The total combined current draw for all modules must not exceed 1.2 A dc for use with a 75 VA transformer and battery backup or 5 A dc for use with a 175 VA transformer and an UPS. To determine the transformer minimum VA rating, the user should calculate the total current for their system.

## Wire The Receiver

### Telephone Connections

Make the following connections between the DML5A Circuit Boards and the DML2A:

<i>First DML5A</i>	<i>DRL2A</i>	<i>Second DML5A</i>	<i>DRL2A</i>
RX1	TxPG1	RX1	TxPG2
TX1	RxRNGG1	TX1	RxRNGG2
RNG	HNDSET1	RNG	HNDSET2
TIP	HNDSET1	TIP	HNDSET2

### Ribbon Wire Connections

Connect the DML5-A circuit boards to the DML2A as shown in the wiring diagram.

### Video Output Connection

Terminal VCN1 on the DML5-A provide video output for use with a monitor or recording device:

- VCN1 provides video output with on-screen display of alarm information

Connect a video monitor or recording device with 75ohm impedance to VCN1.

## Program the MLR2-DG Receiver

Program the following options in the MLR2-DG Receiver:

<i>Option</i>	<i>Item</i>	<i>Program As</i>
Option [4E]	VIDEO DWNLK	A1
Option [5E]	INTER BURST	A1

## Relay Outputs

### Relay 1: NC1, NO1 and C1 Terminals

Relay 1 will activate for several seconds after data is received from the DRL2A Module. This relay may be used to activate time lapse video recording equipment.

### Relay 2: NC2, NO2 and C2 Terminals

Relay 2 will be activated for as long as video images are received by the MLRV-A Module. This relay may be used to activate video recording equipment.

### Relay 3: NC3, NO3 and C3 Terminals

Relay 3 will activate momentarily after each video image is received. This relay may be used with a video recording or printing device.

## Error Information

The MLRV-A can advise of problems encountered during the receipt of video information and in the serial communications between the MLRV-A and the DRL2A. The MLRV-A can indicate errors using the sounder and on-screen display messages. If the sounder or on-screen display functions are disabled, the error messages will not be indicated.

### Error Indications: Sounder

3 long tones	Video data timeout; data transmission is too long
3 short tones	Syncpulse too early; data transmission is too short
1 long, 2 short tones	Syncpulse too long
2 long, 2 short tones	Serial Error: Stop byte error
2 long, 3 short tones	Serial Error: String length error
2 long, 4 short tones	Serial Error: Parity error

### Error Indications: On-Screen Display

"Error #1"	Bad syncpulse from alarm transmitter
"Error #2"	Data transmission too long without sync
"Error #3"	Data transmission too short with sync
"Error #4"	Bad data
"Error #5"	No video present at DLM-4

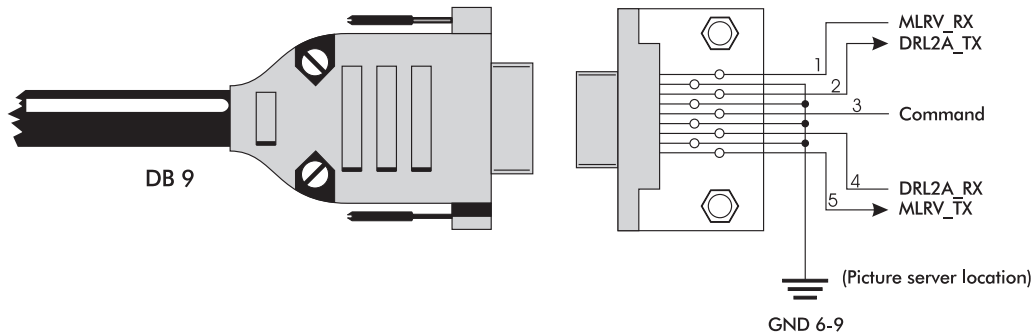
## Video Connection

The DML5-A Video port must be connected to a Listed Video Equipment monitor. The monitor shall be located in the same room as the receiver.

### Video Activation Protocol Lines

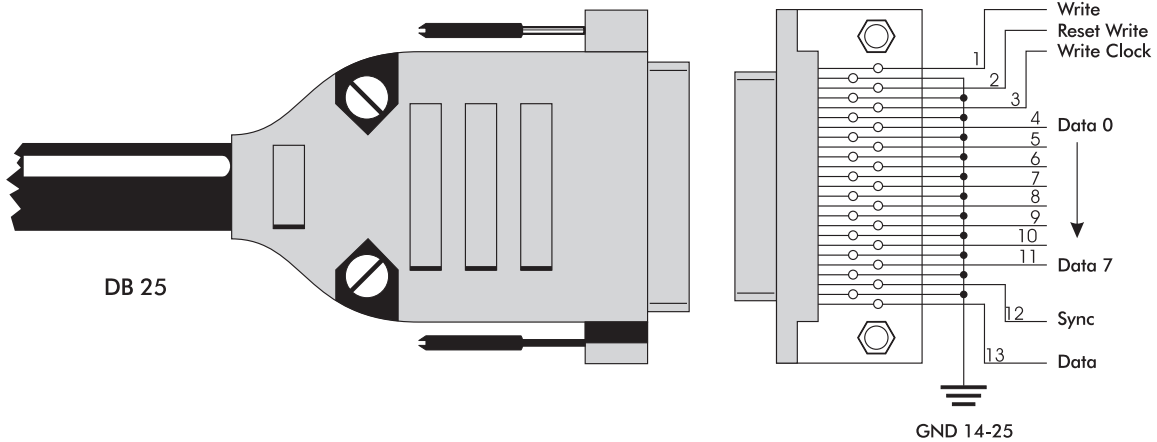


#### Signal Routing:

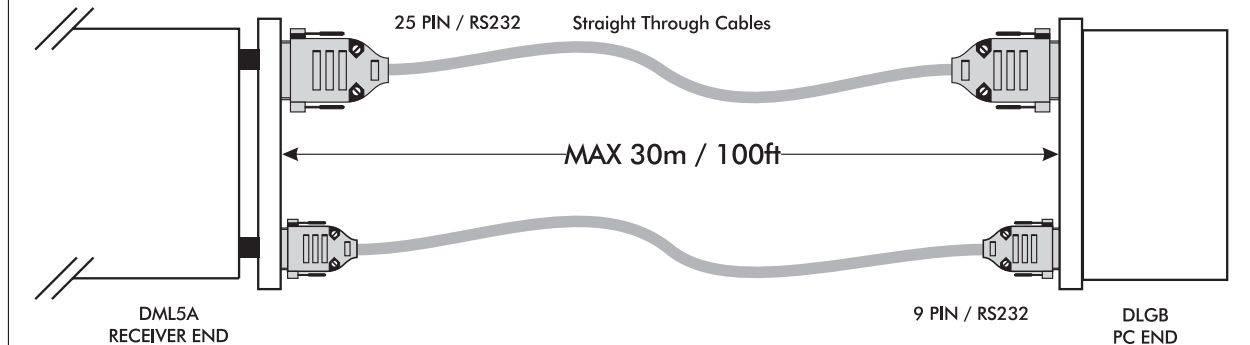
**Send:** DRL2A\_RX to DML5 backplane board to Picture server back to DML5A going into MLRV-A\_RX

### Downlook Picture Bus Lines



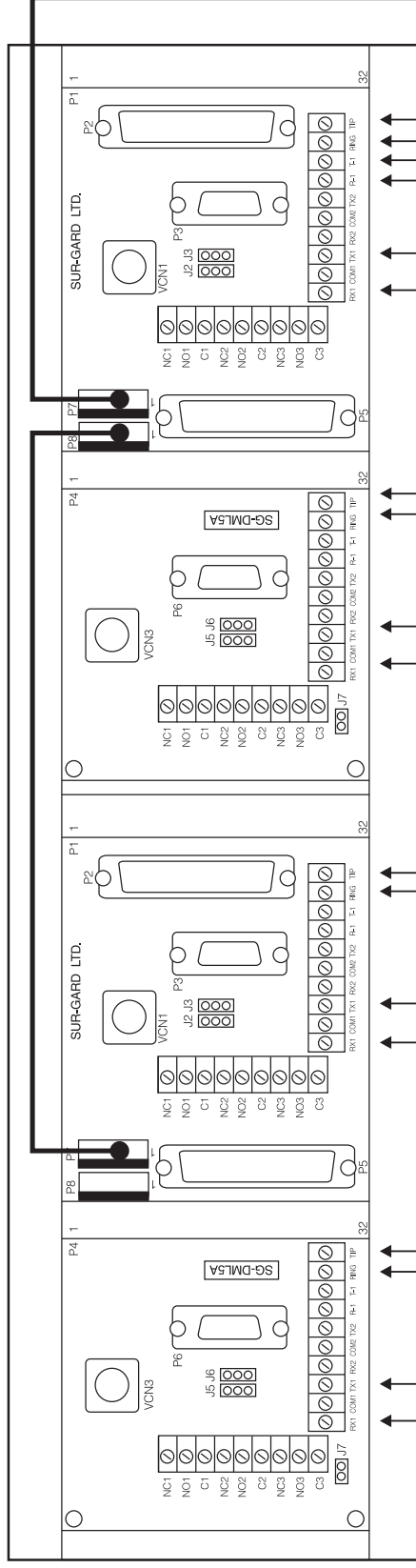

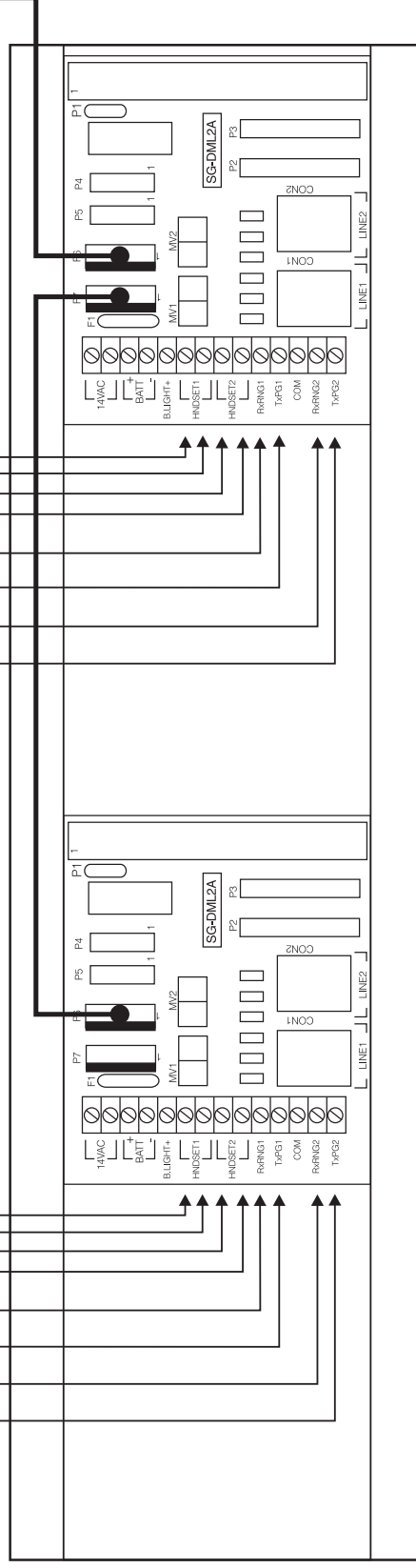


# SG-MLRXV Rear View Connection Diagram

### **Telephone Connection Requirements**

To be certain of the number of devices that you may connect to your line, you may want to contact your local telephone company.
