1. Introduction

The PG4WLSHW8 is a two-way wireless PowerG Hardwired to Wireless Converter. The device has the following features:

- Functions in temperature range -10 °C to +55 °C and up to 93%RH
- Powered by external AC/DC adapter with output rated 18V/2.2A and provided with rechargeable, 24h backup battery, rated 12V/7Ah
- Integrated tamper protection for enclosure door opening and removal of enclosure from mounting position
- Eight hard-wired zone inputs, programmable as either NO, NC, or EOL or DEOL for use with hardwired initiating devices
- Corbus connectivity for adding Keypads, zone expanders or additional power supplies in the system
- Four programmable outputs and one Bell output
- Automatic periodic supervision at regular intervals
- Integral RF transmitter circuitry using PowerG two-way protocol, operating in 433MHz band



