

The Communique modem card, in addition to acting as the telephone system's modem, provides a 1200 baud modem for remote diagnostics using standard terminal emulation software; the card includes two RS232 ports – up to 9600 baud – for on-site diagnostics using standard terminal emulation software.

Connecting the Modem Card

To connect the modem card to the Communique control unit, perform the following:

1. Remove the top nut from the screw located at the bottom right-hand corner of the modem card area on the control unit.
2. Fasten the standoff provided with the modem card to the modem card screw on the control unit.
3. Place the modem card on top of the standoff and replace the nut to secure it into place (see Figure 1 below).
4. Line up the pins on the modem card to the modem card connector on the control unit. Line up all pins with the connectors before pushing them into place. Ensure that all pins make contact with the connector sockets.




NOTE: You must ensure that proper connections are made before applying power to the control unit.

Setting Serial Port Baud Rates

Baud rates for serial communications via a modem can be programmed at 1200, 2400, 4800 or 9600 bits per second. The default setting for both serial ports is 1200 baud.

To connect the modem card to your computer, run a 6-conductor cable from jacks J2 and/or J3 to the COM ports on your computer. Ports 1 and 2 are telephone jacks J2 and J3 on the modem card.

To program baud rates, enter installer's programming by pressing the PGM key three times and press the Line 7 key twice. Station keys 10 and 11 – corresponding to serial ports 1 and 2 – will be lit and the display will read...

```
Select Port 1
or Port 2
```

To view the current programming status of each port, press the corresponding Station key. To program the port, press the corresponding Station key again (for example, the Station 10 key, or port 1). The display will read...

```
Serial Port 1
Baud Rate = 1200
```

The Station keys 10 through 13 will be lit, each corresponding to a different Baud rate. Press the keys one after the other until the desired Baud rate is displayed. Press the PGM key to select and save the rate on the display.

NOTE: If using the Communique modem remotely, the baud rate must be set at 1200. For remote diagnostics, you must obtain the remote access PIN from the user if one has been programmed.

Station Message Detail Recording

With Station Message Detail Recording, the system will report all line activity. The SMDR report can be viewed on a computer using standard terminal emulation software, or can be printed using any serial printer. Call information will appear as follows:

To enable SMDR reporting, enter installer's programming by pressing the PGM key three times. Press the Station 14 key twice. Station keys 10 and 11 will turn on and the display will read...

```
Serial Port for
SMDR Enabled/Disabled
```

To enable SMDR reporting, press the Station 10 key. To disable SMDR reporting, press the Station 11 key. When the desired setting has been selected, press the PGM key.
